Eligibility:

1. Qualifying contractors must complete the registration form and receive a certificate provided by CertainTeed to be part of the CertainTeed Credentialed Contractor Program.
2. Contractors must submit invoices along with a submittal form (via fax, mail or email) **WITHIN 90 DAYS** of the invoice date to receive credit for those purchases. Once submitted and verified, purchases will be reflected on the account.
SPECIAL NOTE: CertainTeed is able to capture the activity of direct buy contractors and will automatically upload those purchases to the accounts of contractors enrolled in the program. Purchases will be automatically uploaded to **www.marketplace.certainteed.com** no later than 30 days following the close of the previous month.
3. Program runs from January 1 – December 31.

Terms and Conditions

1. In the event of a dispute with respect to (A) a Participant's eligibility to participate in the program or (B) the account balance of a Participant, the decision of CertainTeed will be final.
