In September 2013, Rochester Home Infusion (RHI) became a new tenant of the Minnesota BioBusiness Center. They have since completed their build-out and have begun serving patients in southern Minneso-RHI provides specialized intravenous medications ta. in the comfort of a patient's home. RHI coordinates patient care with medical professionals and health insurance to ensure a seamless transition to everyday life.

Xcede Technologies

Xcede Technologies was formed in January 2013 to develop a high-strength, fast-acting combination hemostat/sealant device with a broad surgical indication. Local inventor, Daniel Ericson, PhD, developed this device as a solution to complications caused by bleeding. RAEDI made a commitment in 2013 to invest \$145,000 of EDF funds in Xcede.

Imanis Life Sciences

Imanis Life Sciences was formed to develop non-invasive in vivo imaging and biosensor technologies that are critical to biomedical research, the development of pharmaceuticals, and ultimately to clinical practice. Imanis hopes to revolutionize the in vivo imaging industry with Non Invasive Solutions (NIS) reporter genes, which are state-of-theart imaging solutions for scientists conducting pre-clinical trials. RAEDI approved a \$50,000 EDF loan to Imanis Life Sciences in 2013 to support the construction of their office/lab facility in the Minnesota BioBusiness Center.

Envirolastech

Envirolastech is a development-stage company planning to create a fully-integrated waste reprocessing company in the Rochester area. The company will use its proprietary technology to yield commercial-grade construction products. They will leverage their technology to convert land-fill and recycled waste to manufactured extruded thermoplastic material. RAEDI has ap-

proved a \$250,000 EDF loan to support Envirolastech's construction of a facility within the City of Rochester.

Economic Growth in the Rochester Area in 2013

Charter Communications Adds Jobs & Expands



During 2013, Charter Communications announced they would add 140 jobs to its business-to-business division in Rochester. Charter employs more than 1,200 people throughout Minnesota. The additional jobs will add to the 800 Charter

employees already based in Rochester. The company has invested more than \$25.1 million in their infrastructure since 2008 throughout Minnesota. Charter has leased 40,000 square-feet of space located on the IBM campus in northwest Rochester to provide the space needed for this expansion.

Rochester Medical Acquired by C.R. Bard, Inc. Expands

In November 2013, Rochester Medical Corp., Stewartville's largest employer and catheter maker, was acquired by medical device maker C.R. Bard, Inc. of New Jersey. The merger represents a great opportunity for the combined companies to create a broad product portfolio

by offering a more-comprehensive range of high-quality urological and continence care products to its customers. Their new 54,000 square-foot production facility, on the main campus in Stewartville, will open in 2014.

Olmsted Medical Center Expansion Projects

In 2013, Olmsted Medical Center (OMC) began construction of a \$28 million, 80,000 square-foot Women's Health Pavilion addition to OMC's hospital in southeast Rochester. It is projected to open in late 2014 and will include an updated and renovated BirthCenter and will also offer services including endocrinology, preventive care and wellness coaching, diagnostic radiology, psychiatry, nutrition services and physical rehabilitation.

OMC also opened brand-new branch clinic facilities in Spring Valley in January 2014, and in Cannon Falls in August 2013. Additionally, OMC added a \$3.3 million, 15,000 square-foot Sports Medicine and Athletic Performance facility on land Women's Health Pavilion rendering immediately west of its Rochester Northwest Clinic. OMC's investment in the sports medicine facility is a result of positive financial performance, the economic strength and continued growth of Rochester, as well as increasing community interest in these services.

EZ Fabrication Expands in Chatfield

EZ Fabricating of Chatfield is expanding into a new location and plans to add 17 news jobs with the help from the City of Chatfield and the Minnesota Investment Fund. The company makes everything from finished chrome furniture parts to industrial railings. They also

EZ will combine various locations in Chatfield to one location after purchasing a building from Tuohy Furniture's St. Albans Place which includes 7.7 acres. Additionally, they plan to include a 19,000 squarefoot expansion so everything can be under one roof.

SBA 504 Project

During 2013, RAEDI. through the SBA 504 program, funded 9 loans for a total investment of \$15.7 million. The servicing portfolio today has a total of 109 loans with an outstanding balance of about \$44 million. RAEDI anticipates this activity not only to re-

sult in new business invest-

Mayo Clinic Ventures - responsible for commercializing Mayo's intellectual property. Receives approximately one invention disclosure each day and has active technology files and licensing agreements with commercial industries in the fields of biomedical engineering, imaging, personalized medicine, medical devices, investigational new drugs, diagnostics, therapeutics and focused efforts in technology-based ventures and start-ups.

MedidaMetrics - a healthcare-performance solutions company that provides the next generation of financial performance solutions for the healthcare industry. The Exact Cost software system gives customers the ability to know real costs of doing business by extracting information from data systems in a low-cost and easy-to-implement way.

Resoundant - a medical technology company dedicated to commercializing magnetic resonance elastography (MRI) and making it available to patients and the world.

Sandlerling Ventures - founded in 1979, Sanderling is among the oldest investment firms dedicated to building new biomedical companies.

Social+Capital Partnership - venture capital firm specializing in growth investments. It targets investing in healthcare, education, financial services, mobile, and technology with a focus on internet technologies.

Versant Ventures - a venture capital firm specializing in investments in game-changing medical devices, biopharmaceuticals and other life science opportunities.

Plans to Diversify Area Economy Evolve

RAEDI, among others, participated in local, regional and state public forums during 2013 to promote passage of DMC. Its successful implementation, over the next 20 years, is expected to result in \$6 billion of new investment and thousands of new jobs. We are excited about DMC and the growth opportunity it represents but also believe the region must devote considerable time, effort and resources to ensure the Rochester area economy becomes more diverse. Partnering to this end, RAEDI and the Rochester Area Chamber of Commerce engaged Atlanta-based Market Street Services to facilitate preparation of a plan. This effort, soon to be known as "The Journey to Growth," will be completed and rolled out in 2014.

In the end, this plan will be complementary to DMC, the City of Rochester and Olmsted County's Comprehensive Plan, and any number of local and regional planning efforts that will launch in the coming months and years.

Mayo Clinic Business Accelerator Opens Doors in 2013

In March 2013, the Mayo Clinic Business Accelerator opened it doors with nine tenants including promising local start-ups. The Accelerator is a partnership between RAEDI, the City of Rochester, and Mayo Clinic. The 2,200 square-foot space is located on the second floor of the Minnesota BioBusiness Center. RAEDI is handling the management and leasing of the space.

After one year, the Accelerator has 21 tenants which include biotechnology businesses, medical device makers, software start-ups, venture capitalists and healthcare consultants.

During the summer months, three MBA students were housed in the accelerator and worked to further Rochester start-ups including Accelerator tenants.

Imanis Life Sciences, founded by Mayo Clinic researchers, is the first biotech start-up that will be "graduating" from the Accelerator in 2014. Imanis' new headquarters will be a separate 1,736 square-foot office space on the first floor of the Minnesota BioBusiness Center.

"We are not only extremely pleased with the number of businesses leasing space in the Accelerator, but we are equally happy with the quality of people, which is a mix of talented entrepreneurs, experienced business people and venture capital firms, says Gary Smith, president of RAEDI.

"Our goal is to bring together like-minded entrepreneurs, investors and advisers to share ideas, resources and expertise, and by doing so, we hope to build a unique ecosystem that supports the spirit of entrepreneurism in Rochester," says Jim Rogers, chair of Mayo Clinic Ventures. **Accelerator Events**

The Accelerator hosts events aimed at educating and promoting entrepreneurial activities in Rochester. These events were attended by over 400 local entrepreneurs and business professionals. In 2013, events included five venture series with venture capitalists and Accelerator tenants including Flagship Ventures, Social+Capital Partnership, Sanderling Ventures, and Icon Venture Partners as well as an investment series on "Introduction to Angel Investing." During Global Entrepreneurship Week in November, events attracted over 100 people and included a presentation by Preventice, Inc. on "Local Mobile Tech and the FDA," and demonstrations from Rochester and Minneapolis based biobusinesses.
