Lots and lots of presidential polls come out seemingly every day. One year before the election, do they matter? Remember Herman Cain in 2012? Hillary Clinton in 2008? Or Scott Walker in 2016?

Gallop, once the polling gold standard, has stopped doing presidential primary polls altogether, but really bad polls will keep coming out. So it is useful to know how to read a poll. At the very least, find out what the questions actually were to determine if the poll has any validity.

Case in point: KSTP's [http://kstp.com/news/stories/s3952441.shtml] latest poll. Note the headline:

"64% of Minnesota voters think Hillary Clinton will be the Democratic nominee for President of the United States."

Now, note the actual question:

"<u>Regardless of how you yourself may vote</u>, which of these Democrats do you think will be the Democratic candidate for President a year from now?"

While it may show what average Minnesotans think on this topic, it is as close to meaningless as you can get. The only thing that matters in a primary is how Democrat or GOP primary folks - a very small subsection of the full electorate - actually vote. Just remember how people were talking about Herman Cain as the GOP nominee - until Republicans actually voted.



## **MLS Compliance Corner**

#### ROOMS!

We have been finding some Residential listings that don't have any rooms listed. Since all homes have rooms, rooms are mandatory and, unfortunately, although it is a **required SEMAR field**, FlexMLS cannot make it a required field from their database. The name of the room and the room level are required, the room dimensions and room remarks are optional.

Also, with regard to Bedrooms - each home has either a Master Bedroom or a Bedroom 1 - not both. Once either Master Bedroom or Bedroom 1 are entered, then proceed to Bedroom 2 and so on.

Keep in mind that MLS Policy #2 requires that you not leave mandatory fields blank and that you do not put incorrect information in those fields.

\* Do not put "incorrect" information into the mandatory fields. There is a \$50 fine per field for putting fictitious information into the mandatory fields.

#### Guidelines for Documents to be sent to MLS Office

In order to make it clear which Change Forms need to be sent to the MLS office, we have created some guidelines here:

If a brokerage enters their own listings, then they only need to send SEMAR the following contracts/forms:

#### Contracts Required

(a) If we request an audit.

- (b) If a listing contract is acquired by your broker/agent within 60 days of an existing listing.
- (c) If a listing is being withheld from the MLS.
- (d) You require a SEMAR staff member to enter your listings into the MLS for a \$20 fee.
- (e) Upon request by the MLS staff.

- Change Forms Required
- (a) Cancellations
- (b) Expired
- (c) Back on Market
- (d) Temp Withdrawn

If you need SEMAR Staff to enter listings on your behalf, then you will need to send all contracts including the Withhold Form, if applicable, and all change forms.

#### Video: Trending Legal Topics

NAR's legal team offers guidance on several key topics, including using drones for commercial purposes, the proper use of the REALTOR® trademark, the new closing rules, and who RPAC can legally solicit for contributions in the NAR's latest <u>Window to the Law</u> video.

#### **Court Allows Horse Ban Challenge to Proceed**

An appellate court has partially reversed a lower court's decision to grant summary judgment to the city of Blue Ash, Ohio, in response to a property owner's claim that the city violated two federal laws by refusing to allow her to keep a horse on her property to help her disabled daughter. In its decision, the United States Court of Appeals for the Sixth Circuit ruled that the property owner had produced enough evidence under the Americans with Disabilities Act for a court to evaluate whether it would be reasonable for her to keep the horse on her property. The appellate court also said the trial court had erred in declining to evaluate the plaintiff's claim that the city had not made a



reasonable modification of its horse ban as required by the Fair Housing Amendments Act. The case was sent back to the lower court for further proceedings. <u>More info. Full text of decision</u>. <u>Related video</u>.
