 - Recipient must be an electric customer Austin Utilities, Owatonna Public Utilities, or Rochester Public Utilities.
 - Due to limited funding, this rebate offer can be withdrawn at any time without notice. Applications will be processed on a first-come, first-serve basis. All applications from this year's purchases (2017) must be received by March 31, 2018.
- ☐ 2. Purchase ENERGY STAR® certified LED bulbs, LED light fixtures, and ceiling fans with LED lighting.
- ☐ 3. Complete the information on the inside of this rebate booklet, making sure to fill out all sections in detail. Allow 6-8 weeks for processing. Missing or incorrect information will increase the processing time.
- ☐ 4. Include your original sales receipt and portion of the packaging showing the ENERGY STAR® logo, manufacturer, model number, bulb wattage, and number of bulbs or fixtures.
- ☐ 5. Sign the application (required to receive rebate).
