The Utility reserves the right to apply rebates to past due accounts. Rebates \$75 and under will be applied to your account. Rebate cannot be combined with any other offer. Rebate cannot exceed the price of the bulb, package, or fixture. Recipient must be an electric customer Austin Utilities, Owatonna Public Utilities, or Rochester Public Utilities. Due to limited funding, this rebate offer can be withdrawn at any time without notice. Applications will be processed on a first-come, first-serve basis. All applications from this year's purchases (2020) must be received by March 31, 2021. 2. Purchase ENERGY STAR® certified LED bulbs, LED light fixtures, and ceiling fans with LED lighting. Complete the information on the inside of this rebate booklet, making sure to fill out all sections in detail. Allow 6-8 weeks for processing. Missing or incorrect information will increase the processing time.
