#### Partnering in Energy Solutions (PIES)

Our PIES financing program can help fund an energy reduction project by offering 0% interest loans, up to \$25,000 for qualified customers. Eligibility requires a 2 year pay history in good standing, and the project must qualify for a Conserve & Save<sup>®</sup> rebate. This financing allows a customer to pay for the project on their bill over a one or two year period at 0% interest.

- Dishwashers
- Refrigerators
- Clothes Washers
- Toilets
- HVAC Equipment
- Custom Efficiency electrical equipment or processes that can be proven to save kWh will be considered

### Total Rebate = \$1,080

\*\*Rebate total is based on Energy Star Most Efficient Appliances, and HVAC over 20,000 btu/hr, irrigation controllers are now 50% of cost up to \$75.

#### **Rebate Application and Processing:**

- After you have identified the energy savings project you would like to pursue for your building, contact an RPU representative below, to help verify that the proposed equipment would qualify for the rebate. Some rebates have very specific efficiency requirements that must be met.
- After the equipment has been installed, complete the rebate application, and include all required information (i.e. copies of invoices, spec sheets, etc., then submit the completed rebate to RPU.
- After the rebate has been received and processed by RPU, the customer will receive a rebate check.
