Community Forum on Mental Health

Spotlight on 2008 Laws and Anticipated Funding and Policy Issues in Next Legislative Session

Rochester, Minn. – Four local mental health organizations are teaming up to offer people with a mental illness, their family members and health care professionals a preview of the behavioral health landscape. Kathleen Kelso, director of public policy, and Ed Eide, executive director, of the Mental Health Association of Minnesota will review new mental health laws and discuss anticipated issues for the state's 2009 legislative session.

The community forum is being held September 11, 2008, at Zumbro Valley Mental Health Center's main campus in Rochester located at 343 Wood Lake Drive SE. It will be held from 2:00 p.m. to 4:00 p.m.

"This forum offers individuals, professionals and others a unique opportunity to learn about legislative changes and their impact on mental health community-based programs," said Patricia Carlson, executive director for Zumbro Valley Mental Health Center. "It provides a clear overview of key updates that can significantly impact how services are provided."

Carlson added the community forum will offer people an opportunity to report what is working for them and what needs improvement in the mental health system in their community. This information will be shared with candidates during political campaigns and with legislators at the Capitol in 2009.

Mental illnesses are biological brain disorders that affect about one in five persons and are the leading cause of disability in the U.S. for ages 15-44. Minnesota has steadily promoted and funded effective treatments and rehabilitation in both the public and private sectors; however, access to full mental health benefits remains limited for many children, adults and their families.

As with other chronic conditions, people get worse while waiting for services, when earlier treatment would avoid complications. Affordable housing, community supports and employment supports are sorely lacking. Treatment and support to children at their schools and homes is difficult to obtain.
